VI. Committee Reports

Committee reports are included in the annual report. There were no questions. Comments from members present – the nursery looks fantastic; thanks to William Nuss for renovating that as part of his Eagle Scout Project. Flood mitigation is done; thanks to Pete for completing that and managing the clean-up and damage/repairs. We now have a French drain and a sump pump to prevent future issues. The new pew cushions are appreciated and wonderful.

VII. Financial Reports

The budget committee, board of managers and D&E prepared and approved the balanced budget presented this morning. Treasurer Jerry Nuss presented financial highlights.

Revenue Highlights: Stewardship campaign reached 95.08% of goal, 109 households pledged. 74.46% of our annual budget is provided by just 30 households, 25.54% of our budget is provided by 79 households, 100 households made no pledge. Please consider pledging as it helps us plan and manage our budget. We made investments in CDs this year.

Expense Highlights: The personnel committee recommends a 3.5% cost of living increase for all full-time staff, including the pastor. The budget includes a new part- time nursery staff person and utility rate increases.

Annual Report of the Pastor

This is what Yahweh says: Stand at the crossroads and look. Ask for the ancient paths, where the good way lies and walk in it and find rest for your souls. ~ Jeremiah 6:16

Jim Davis and Michael Graham wrote a compelling book entitled, "The Great De-Churching" (2023). In the book, Davis and Graham seek to answer the questions: Who is leaving? Why are they going? What will it take to bring them back?

Who is leaving? Simply stated, there is a mass exodus from all Christian churches since the 1990s, a trend that accelerated during the pandemic. No denomination is exempt from this migration. There *is* a generational component to this exodus: newer generations are less engaged with churches and more apt to support causes which align with their personal views.

Why are they going? Some members leave due to apathy: kids grew up and they were less engaged, or they got out of the habit during the pandemic. Other left because the church became too politicized, or their beliefs diverged from that of the pastor or congregation. Still others, tragically, left because the church caused them physical or emotional or spiritual harm. Davis and Graham also identified the proliferation of views on the internet as a cause for de-churching.

What will it take to bring them back? There is good news, however. Davis and Graham found that *more than half of those who de-churched would be willing to come back if invited and made to feel welcome.* Did you get that? Over half...would come back...if invited...and made welcome. Friends, those seem like simple and easy things to do!

Davis and Graham identify three themes in which healthy, thriving congregations may re-engage with the de-churched: Belief, Belonging, and Behavior.

- **Belief**: In the Gospel of Jesus Christ, the church has something unique and hope-filled to offer the world. Christians, as children of God, forgiven and redeemed, and called to serve others, must maintain that identity amid the world's competing claims. This is counter-cultural, but it offsets the negativity and self-centeredness of the world.
- **Belonging**: Jesus was known for his radical hospitality, welcoming outcasts and sinners to his table. Jesus invited people from all walks of life into God's realm. He talked with them and made them welcome. A church that presents this kind of radical welcome will become a safe space to which de-churched people may return.
- **Behavior**: A church whose words and beliefs do not correspond to their actions is deceitful. But a church that lives out its faith by engaging in acts of love and service will be a church that entices people to re-engage.

I am eager to discover with you where the Holy Spirit will lead us in 2025. My prayer is that Federated Church will continue to be a community rooted in Christ, empowered by the Spirit, and committed to spiritual growth, deep relationships, and courageous action.

Christian Education

The Rev. Karen Anderson

This past year brought many fresh faces and great energy to the Christian Education programs here at Federated. Our children's and youth ministries continue to grow in number, matched by an increase in volunteers and support. We are encouraged by these trends and pray that they continue in coming years.

Kidz Club: Kidz Club began the year (our winter/spring session) continuing our theme of the year of Jesus. We focused on His life and ministry, the miracles He performed, and His death and resurrection. This fall we began a new series on the life of Joseph, studying his life journey from favored son to slave to pharaoh's right-hand man. We learned that no matter what our circumstances, God is present and working behind the scenes for His glory and our blessing. We capped off the year with our annual Christmas pageant, in which we told the story of the birth of our Savior, Jesus Christ, during Sunday worship. It was a wonderful year with church families inviting friends to join us! We have snack time, story and music time, crafts, and gym time. Our wonderful volunteers include Caroline Anderson, Siri Anthonisen-Brown, Melissa Davenport, Jonathan Dent, Lu Echelberger, Claire Gutzmer, Sheila Rodning, Beth Schlepp, and Char Zielin. In the kitchen we are blessed with the leadership of Roxane Nereson, Jane Nelson, and Gail Green. This ministry requires a huge group effort, and we have developed a wonderful team! Please let me know if you would like to serve with us—we are always willing to welcome more help!

Sunday School: Our Sunday School program serves a faithful group of children with a faithful team of dedicated teachers. Once again, our teaching team consisted of Jona Brown and Madalyn Dent with our younger group (K-1st), Sam Ebert, Kristian Fransen, and Karen Anderson-Dent with our older elementary group (2nd-6th). Our theme this fall was on the "13 Most Important Things About God". We covered topics such as "God as Triune," "God is good," "God as human and divine," "God is eternal," among others. It is good practice to begin the process of introducing these concepts at an early age, from which we can build upon during their time in confirmation and beyond. Our children have a wonderful capacity to understand ideas that are challenging.

Confirmation: Our confirmation classes continue to meet each Wednesday (7th-8th grade after school, 9th at 6:30pm) under the leadership of Pastor Doug and assistance from Char Zielin and Hollis Davenport. They cover the Old/New Testament and topics of theology and faith as laid out in the curriculum written by Pastors Doug and Karen. Once a month or so our 7th-8th grade students get to have a "break" by engaging in a youth group time rather than confirmation class. This is led by Pastor Karen, giving them a chance to exercise their faith in various discussions. They also get to do some traditional "youth group" activities and games, as well as occasionally assisting in preparing and serving church meals. This past spring we were able to resume our once or twice a year participation in Meals by Wheels with church members, which we follow by going out for lunch. This is a highly popular activity as the youth get to leave school for a few hours to do this important volunteer work. We had our annual fall retreat at Clearwater Forest in mid-September. Our topic this year was on the life of Joseph. His story is one of great challenges, and we related it to our own lives by recognizing that God is ALWAYS present to work through our circumstances for His glory and our blessing. We had a great leadership team with Madalyn Dent, Hollis Davenport, Sam Ebert, Molly Stoddard, Jennifer Jorde (my sister), and older youth leaders Gabe Carlson, Chloe Cruz, Jonathan Dent, Claire Gutzmer, and Siri Anthonisen-Brown. It is such a fantastic way to kick off the year on this annual retreat.

Senior High Youth Group: Our senior high youth group met each Wednesday night under the leadership team of Karen Anderson-Dent, Hollis Davenport, Madalyn Dent, and Molly Stoddard. Every week we try to address a topic identified as "interesting" by our youth-who are asked at the beginning of the year. We do our best to encourage one another to find ways to live out our faith in Jesus Christ while discussing current issues and challenges we face in the world. Topics this year include human cloning, living in community,

what are demons, do giants exist, what is hell, what is satanism, who do you trust, etc. We have fun talking about these issues and we have fun playing lots of games! Our winter retreat in January 2024 had the theme "Who Does God Say I am? Discovering Our Purpose!" We spent time learning more about what gifts God has placed in each of us and exploring how He might want us to use those gifts as we serve others in the world. We also took time to rest, reflect, enjoy the outdoors, create walking sticks, and play lots of games. We were so excited that God provided a beautiful covering of snow for our weekend, in an otherwise not-so-snowy winter!

Adult Bible Studies: Our women's Bible study meets each Tuesday morning at 11:15 am for a time of prayer and study. This year we completed our study of 1 and 2 Samuel, and then we went through Paul's letter to the Colossians this autumn. We deeply enjoy the fellowship, learning, and encouragement generated in this group! We are an open and welcoming group, adding new members and guests. The Revelation Bible study began meeting on Mondays at 6:30pm in January of 2024. We made it through chapter 11 by the summer and chose to take a break until fall. This autumn we picked up several new people and decided to spend time in review of what we already studied (not a bad idea when going through this book of the Bible!) We will begin at chapter 12 in January of 2025 during Fellowship Hour on Sundays. Both groups are people hungry to have a better understanding of God's word and how it applies to our everyday lives. It is a wonderful time to learn and support one another in our discernment of scripture!

Vacation Bible School: We had our annual Vacation Bible School during the week of June 24-28. We had a great turnout—our numbers continue to grow as we add families and friends to our group. Our theme this year was on the "God of Wonders." Each day we focused on a different component of the heavenly realm—the sun, the moon, the stars, the planets, the earth--hearing Bible stories that reference it and creating art that reflect it. Our verse theme was "Let your light shine before others, that they may see your good deeds and glorify your Father in heaven!" Matthew 5:16. We had wonderful youth and adult volunteers who helped make it a spectacular week.

2024 was a year filled with rich experiences, wonderful learning, fellowship, and lots of fun! The great activities and energy would not be possible without the faithful and creative volunteer leaders who help make this such a successful ministry! I look forward to seeing what God has in store for us in 2025!

The Fellowship Committee organizes social events to help build community.

Highlights of 2024:

- **Rally Day (September 2024)** A large group of our congregation stuck around after church to enjoy home-made pulled pork sandwiches and baked beans. The people at the tables competed in bingo, and the younger children enjoyed the bouncy house outside.
- **2024 Potluck Meals (Palm Sunday 2024 and November 2024)** These have turned out to be highly anticipated events with lots of participation from chefs in our congregation. We would like to thank Pete Konrad for setting up serving tables for these meals.
- **Birthday Cake Sunday (February 2024) Matt** Solin has been a big influence to make this one of our bigger events of the year. Extra cakes were auctioned off to supplement our committee's 2024 budget.
- **Softball Breakfast and Silent Auction (April 2024)** The softball teams raised over \$1,000 to help finance team expenses and make progress to get the church softball account out of the red.
- **Softball Tailgating Event (August 2024)** A picnic lunch was provided before the last regular season game of the season for our softball players to enjoy brats and beans with their families and "rub elbows" with the Federated softball fans.
- **Pie Social (October 2024)** This has become one of our larger events with over 25 pies being contributed by our talented pie-bakers. The extra pies were auctioned off, raising almost \$600 for the Local Mission Fund.

Mission Committee

Thanks to the generosity of congregation members through their financial giving, the Mission Committee was able to give \$8,000 to 13 local, national, and international organizations during 2024 and support three missions within Federated Church.

Highlights of the Mission Committee year were:

- Once again, the committee was responsible for recruiting and coordinating volunteer drivers to deliver Meals by Wheels throughout the year. Thank you to Char for her work in contacting volunteers, and a HUGE thank you to all the Federated members who so willingly delivered meals and brightened the days of recipients.
- During FoodShare Month in March, we continued the Mission Committee tradition of matching congregational donations, contributing \$700 to the Fergus Falls Community Food Shelf.
- Our two Muffins for Mission events in (June and August) raised \$397 for A Place to Belong and \$709 for Boxes of Blessings at the Cancer Care Center; the committee provided a \$100 match for each of these donations.
- The Mission Brunch was an overwhelming success! Representatives of Barbara House, a local sober house for women, shared their moving stories about impact that the non-profit organization has had on their lives. Congregational donations during the brunch totaled \$3,676, and the committee contributed an additional \$2,000 for a total donation of \$5,676.
- For needs within our own congregation, we provided \$500 in support of the Local Mission Fund; \$800 for meals for Kids Club; and up to \$700 for confirmand donations (\$100 per confirmand).
- One Great Hour of Sharing received a donation (match) of \$300, and the Christmas Joy offering in December (after the deadline for annual report articles) will receive a \$200 match from the Mission Committee.
- In response to hurricanes in the South during the fall, the committee donated \$500 for denominational disaster relief and \$400 for hurricane clean-up buckets through Church World Services.
- Also supported through the Mission Committee during the year were Bio Girls (\$500); YMCA Youth Development (\$500); Habitat for Humanity (\$125 for a lunch for hungry volunteers), Bible Bingo at the Pioneer Home (\$150); Salvation Army Food Program (\$325); and Clearwater Forest (\$100).

Our committee's goals in giving were 70% local, 20% state/national and 10% international.

Pastoral Care

With the help of volunteer drivers (Renee and Russ Larsen, John MacFarlane, Dave Nord, Lu Echelberger, Char Zielen, Bill and Peg and Paul Shol) we delivered 87 porch bags/meals this year. This is a ministry that continues to share a meal with those that are at home, sick, healing, mourning, experiencing joy or just maybe need an extra "hug" from the congregation. This simple meal consists of soup, bread, a sweet treat, devotion, and a handwritten note.

83 Boxes of Blessing were delivered to the Fergus Falls Cancer Center. This continues to be an outreach and mission project for our congregation. A team of nurses and staff at the center put together a list of helpful items to gift those that are starting to receive treatments. We also delivered boxes of blessings to 2 people receiving treatment at other facilities. Thank you to the youth group who helped put together many of these boxes. Thank you for the generous monetary donations to keep this project going.

The Federated Mission Fund used \$507 as outreach for meals and those in need within our faith family.

The Local Mission fund used \$3,421 to help individuals in our community with food vouchers and utility bills. This is a wonderful mission that Federated can offer to our community and those that are struggling.
